3. 1/4 of the award vested on the transaction date. The remaining 87,100 RSUs vests ratably as to 1/4 of the total award on the 3rd of each June, September, and December thereafter.

4. These RSUs do not expire; they either vest or are cancelled prior to the vesting date.
